## **Decision - 2016 Airport Charges**

I would like to thank you for your participation in the 2016 Heathrow Airport Charges Consultation process. The consultation process began on 7 August 2015. Heathrow Airport Limited ("Heathrow") held a formal consultation meeting on 15 September 2015 and received four formal written responses to its proposal.

We have carefully considered all airline and airline representative body responses on our price proposals, which include all the comments expressed at the consultation meeting and written responses. All received feedback will be provided with a separate reply to directly respond to the comments made by the representative. Heathrow has come to a decision that it will recover the 2016 forecast maximum allowable yield of £22.118. This is a 2.2% reduction compared to the 2015 forecast maximum allowable yield.

Heathrow's vision "to give passengers the best airport service in the world" puts passengers at the heart of all we do. The pricing decision enables Heathrow to recover previous capital expenditure that has helped transform Heathrow Airport to be recognised as the "Best airport in Western Europe" reflecting the excellent passenger service. The recovery of the maximum allowable yield follows the CAA's settlement for Q6, which was made after an extensive consultative process. Heathrow will maintain its focus on transforming the service we give to our passengers and airlines, improving punctuality and resilience.

Finally, Heathrow announced its decision on the future structure of charges on 5 August 2015. The future structure of charges that has been consulted upon has a 2017 planned implementation date. This means the structure of airport charges for 2016 is unchanged. **Appendix 1** sets out the final prices effective from 1 January 2016.
